- ✓ Publicly acknowledged or has published data demonstrating that synthetic alternatives are effective and appropriate for the testing of water in the manufacturing process (5 points)
- ✓ Publicly acknowledged or has published data demonstrating that synthetic alternatives are viable for your company (5 points)
- ✓ Developed a business contingency plan in the event of a major supply chain disruption of LAL (5 points)
- ✓ Published comparison data for synthetic alternatives and LAL as it applies to your company's work (5 points)

Category 3 - Reduce the Use of LAL

Your company:

- ✓ Has established a time frame for reducing the use of animal-derived LAL by switching to synthetic alternatives for water testing or microfluidics (5 points)

- ✓ Is transitioning the use of water testing from LAL to microfluidics (5 points)
- ✓ Has converted a significant portion of their water testing from their LAL use (>80%) to synthetic alternatives or via microfluidics (5 points)
